

The Regional Development Agency of Western Macedonia S.A.-ANKO, completed successfully the 1st and 2nd Online Workshop of the Project SmartRural «Smart Rural Entrepreneurship».

1st SmartRural WORKSHOP

The online event took place on Wednesday, December 9, 2020 between 09: 00 and 11: 45. The Workshop was implemented through the Zoom platform. The Workshop was also broadcasted live through ANKO Facebook page.

The subject of the 1st Educational Workshop was: "Business Activity in Rural Areas".

















The Workshop has been conducted in three Sessions. The 1st Session was an introduction to the Seminar and a presentation of the SmartRural Project.

The topics presented in the 2nd Session were Globalization and its consequences for SME's in the European countryside and an Introduction to European rural areas. The 3rd and final Session of the Workshop included presentations of the Common Agricultural Policy (CAP) and the Policies to enhance entrepreneurship in the countryside.

The Evaluation Form of the 1st Workshop was sent to all participants and was filled by a total of eleven (11) attendees, who were asked to answer nine (9) questions with the answers receiving values on a scale from one (1) to five (5). The results of the evaluation are judged as positive as the majority of participants were satisfied with the topics discussed, the presentations and the speakers of the Workshop.

The online event took place on Friday, December 18, 2020 between 09: 00 and 11: 45. The Workshop was implemented through the Zoom platform. The Workshop was also broadcasted live through ANKO Facebook page.

The subject of the 2nd Educational Workshop was: "Entrepreneurship and Innovation in Rural Areas"

The 2nd Workshop was split in three sessions. The 1st Session was an introduction to the Seminar and a brief Review of the results of the previous (1st) Workshop. The themes of the 2nd Session were, Business Trends in Greek Rural Areas and the New Technologies and Innovation in Agricultural Production and Alternative Tourism. The 3rd and final session of the Workshop was a demonstration of the Tools of the SmartRural Project.

Questionnaires were produced and submitted electronically to the participants at the conclusion of the event in order to ensure the continuous development of the services and to ensure the consistency of the educational activity and the improvement of the next acts, with the intention of gathering feedback, observations etc. in order to enhance the educational procedure.

The steps to be taken to carry out the next workshops will include the review of the data from the first two Workshops to identify and strengthen any gaps, as well as closer communication with stakeholders and groups involved, and also the collection of information for the operation and evaluation of the SmartRural Center's actions.









































BULGARIA ECONOMIC FORUM HAS LAUNCHED THE IMPLEMENTATION OF THE THREE PILOT APPLICATIONS OF THE SMARTRURAL BUSINESS MODEL

The implementation started with a Preparatory Plan whose purpose was to provide information on the implementation of the pilot activities in their various phases, in accordance with the needs of the participants. It was developed in three parts - Analysis and goal setting, Phases of implementation of the pilot activities and Schedule for implementation.

A methodology for selection of participants was developed where the contribution of the selection methodology, its objectives, the methodological framework and the expected results were described. The document contains the criteria for eligibility and evaluation of candidates, application form, evaluation matrix based on completed application forms, evaluation matrix through interview, format of the long and final list of selected candidates.

A dedicated landing page was developed for more successful online attraction of candidates with the possibility for automatic data collection from those wishing to participate in the pilots. The total number of completed application forms was 15. Among them, three candidates were selected.

The pilot applications were implemented in several stages:

 Providing a package for training and introduction to the electronic platform of the project;

















- Conducting individual consultations based on the specific business idea / business activity that the participant develops;
- Providing a personalized card with expert guidelines and recommendations for action to each participant.

In connection with the COVID-19, the consultations were carried out online via the Skype platform. The participants expressed their satisfaction with the received expert services and training materials and their readiness for future cooperation.

LEDA-RAZLOG FROM BULGARIA, PP5, IMPLEMENTED DELIVERABLE 2.5.3 ORGANIZATION OF AN INFO DAY.
